

### Risk Assessment Guidelines

Rous Water's '**Commercial Activities on Rous Water Operational Land: General Information**' provides details of the information required to be lodged with your '**Application for a Temporary Permit – For use of Rous Water Operational Land**'.

Applicants lodging a permit application are required to prepare, submit to Council and adhere to a documented *Risk and Safety (Operations) Management Plan* according to legislative requirements.

Applicants must ensure compliance with the *Work Health and Safety Act 2011 (WHS Act)*.

An essential component of a Risk and Safety (Operations) Management Plan is a **Risk Assessment**.

A **Risk Assessment** must cover the whole operations of your activity and take into account:

- (a) Identification of all potential hazards posed by your activity; and
- (b) Likelihood of consequences / outcomes of these hazards; and
- (c) Potential risk of the hazard and appropriate control of identified hazards, i.e. what needs to be done to eliminate or control the risk e.g. first aid, emergency response and evacuation plan.

To complete a **Risk Assessment** you can either:

- 1. Complete the following form; or
- 2. Prepare your own risk assessment.

Your commercial activities Risk Assessment is to be lodged as part of your '**Application for a Temporary Permit – For use of Rous Water Operational Land**'.

Rous Water will review the risk assessment lodged as part of your application to verify that it appears to be appropriate for the nature and extent of the proposed activity. However in undertaking this review Rous Water is unable to verify the adequacy of the assessment provided by the applicant, nor the risk management measures adopted.

# Risk Assessment Matrix

## WHAT IS THE POTENTIAL RISK OF THE HAZARD?

- Select a likelihood and a consequence for the hazard on the RISK MATRIX using the definitions to assist you.
- Determine your risk level by joining your likelihood and consequence for the hazard on the matrix i.e. low, medium, high or extreme.
- Write the potential risk of each hazard on the form.

Risk Level	Recommended Actions
Extreme	Immediate action required – Activity must not proceed until steps are taken to reduce risk to as low as reasonably practicable using the hierarchy of controls
High	Risk control measures required to reduce risks to as low as reasonably practicable using the hierarchy of controls
Medium	Review risk assessment and ensure control measures to reduce risk to as low as reasonably practicable using the hierarchy of controls
Low	Manage risks by routine procedures and monitor
