Schedule 2: Prohibited matter

Biosecurity Act 2015

Part 1 and Part 2 below have been extracted from Schedule 2 as specifically weed related. For all prohibited matter, see [Schedule 2](#) of the *Biosecurity Act 2015*.

Part 1: Prohibited matter – throughout the State

‘A person who deals with prohibited matter or a carrier of prohibited matter is guilty of an offence. A person who becomes aware of or suspects the presence of prohibited matter must immediately notify the Department of Primary Industries.’
